The deadline for providing input is **September 28, 2016 by 12:00 noon**. This deadline is necessary to incorporate your feedback, complete editing and design work, and have a final copy ready for approval at the November Board of Trustees' meeting.

- submitted to Marketing and Communication for final editing, formatting, and binding,
- submitted to the Board of Trustees, and
- submitted to the ACCJC in advance of the March 6-9, 2017, Accreditation Site Visit!!
